Sovereignty

Your Majesty

At Your Majesty's Coronation you will recall the people of the United Kingdom handed to Your Majesty their sovereignty so that you could administer that sovereignty of the people in our name and only ever in our best interests.

At the Coronation in return for the people placing their sovereignty in Your Majesty's hands, Your Majesty took an oath before God and to your people that you would rule us according to our laws and customs. As it was given to William and Mary in 1689, the commons had no authority in 1911 to force the Parliament Act through, and by use of threats restricting the powers of the House of Lords, and by so doing breaking a protection given to us by our ancestors who foresaw the need to protect us their descendents from despotic government. Nor did parliament in the shape of the House of Commons have our authority to restrict the Royal Prerogative by telling your much loved Grandfather King George 5th that he kept all his prerogative but could not use any of them unless he had the backing of a minister.

Nowhere in our constitutional documents was this power ever given to parliament. The Declaration and Bill of Rights 1688/9 gave no such authority being a simple restatement of the minimum rights and freedoms which the people of these Islands insist are observed by those in whom we place the day to day running of our country.

The Constitutional Laws of England have since Alfred the Great refused to accept Foreign laws or authority in this country. Edward Heath, in taking us into the EEC and lying through his government about the effects on the Sovereignty and Constitution of the United Kingdom, set out to subvert our Ancient Constitution, the Major Crime of Sedition; and to hand over Your Majesty's Kingdom to the domination of a foreign power the EEC/EU, the Major Crime of Treason, crimes every government since Heath's has been enthusiastically engaged in committing. Each and every government minister for the last forty years has ridden roughshod over the Acts of Supremacy 1559, Praemunire 1392, the 1351 Treason Act, the 1848 Treason Felony Act and Sedition at Common Law, to name just a few.

As a result of gross abuses of authority up to and including Sedition and Treason by Your Majesty's governments leading up to the signing of the Treaty of Lisbon, a gross abuse of authority of parliament to govern, facilitated by the repeal of the Act of Praemunire 1392, by which criminal act parliament placed Your Majesty's Courts under the domination of foreign courts over which Your Majesty has no control, and the total refusal of parliament to recognize the authority of Magna Carta 1215 the Petition of Rights 1628, the Habeas Corpus Reform Act 1679, and the Declaration and Bill of Rights 1688/9. Each of these Major Constitutional Laws is among the laws Your Majesty Swore an Oath to rule us by.

Your Majesty may recall being asked whether you were still sovereign. The Justice Ministry in the reply dated 14th November 2006 stated that Your Majesty no longer had any political or executive authority in the land, but you were useful for opening parliament and meeting Foreign Dignitaries. Let us skip over the complete lack of understanding of Your Majesty's Role as Supreme Governor of Your Majesty's Loyal Subjects of every political persuasion and as such Your Majesty is politically neutral. And as Supreme Governor of the Established Church, whereby Your Majesty is required to legislate always using God's laws as your guiding principle. Laws accepted by the people of these Islands for hundreds of years as the only true and right laws for us. John Major after Maastricht said that Your Majesty was now a citizen of Europe thereby taking away Your Majesty's Style and Honour as the Queen of England! This was a clear act of Treason under the 1351 Treason Act and the 1848 Treason Felony Act. By not throwing him in the Tower to await execution you did nothing as though your titles were worth nothing, and by doing nothing you let down your office and your people. I would remind Your Majesty that for a thousand years Englishmen have died to preserve the High Honour of England and England's Kings. If asked they would continue to die to preserve it for another thousand years.

It has become increasingly obvious to many of Your Majesty's Loyal Subjects, of whom there are more than parliament may lead Your Majesty to believe exist, that the oath Your Majesty took to your people in 1953 has been broken so many times that it now resembles the most tattered Ensign ever seen after Your Majesty's forces have been engaged in action against the most resolute enemy.

That being the case it is with the utmost sorrow that I now take back my sovereignty from Your Majesty. In recovering my sovereignty I wholeheartedly reject now and for all time any suggestion that my sovereignty has passed to parliament, or that I am now or ever will be a citizen of Europe, I was born and will remain as will my children and their children behind them Freeborn English men and women. I reject fully the authority of any laws or regulations imposed upon the United Kingdom from any foreign Prince, Person, State or Prelate even though they have been accepted by your Majesty's parliament. For me to do otherwise would be for me to commit the Major Crimes of Praemunire and Treason, and I would die before I would betray the country of my birth.

Many Englishmen and women like myself are prepared to fight and die to preserve England as a free self governing country, as Englishmen and women always have. I am aware that the majority of Scots and Welsh feel the same profound desire to remain free of foreign rule. I most earnestly urge Your Majesty to join with us your people, enforce your Coronation Oath break the illegal tie your government has made with Europe against every single piece of constitutional law we have, not to mention the overwhelming will of the people that we should control our own destiny.

Your Majesty need to have no fear for the Royal Household. Join with us and your people will see you and yours come to no harm. Besides – who could ever harm you, you are protected by the Brigade of Guards all of whom are loyal to Your Majesty.
